- Call to Order: 5:30PM.
- 2. **Adoption of the Agenda:** Bradley as President presented the agenda. Bill made a motion to adopt the agenda. Joe seconded the motion. Carried.
- 3. **Reading & Approval of the Minutes**: Bill made a motion to adopt April minutes. Seconded by Josh. Carried.
- 4. Officer's Reports:
 - A. Treasurer's Report Joshua:
 - a. The treasurer had no written report but stated that the Chapter has \$8,767.00 on hand. He has received 2 new member's dues and had reimbursed Joe Garcia \$255.00.
 - b. Beth stated that very few votes have been sent to the Secretary on the 2015 budget approval. Beth needs 2/3 of membership or 96 people to respond.
 - B. Executive Director's Report –Ann reported on a Florida Community Design Center program regarding pop-up parks which is to start on Parking Day 9/18. The location of the event is adjacent to the Headquarters on the side street. Ann is asking for funds from AIA Gainesville to finance this publication which initial publication was for 100 copies.

Ann is asking for ideas and displays for the new Main Street Headquarters' windows and walls.

5. President's Report:

- a. Bradley spoke about the time table that the State AIA has established for accreditation paperwork required to keep Chapter status. The chapter has one year or to next March to fill out the application for recertification. He reviewed the time of activities that the status of Chapter requires and he suggested that the Board start to fill in the paperwork as soon as possible. The activities include:

- will send money to State AIA for distribution and it will be distributed per population of each Florida AIA entity which he estates will mean only \$3,360.00 a year to our Chapter.
- c. Discussion occurred regarding having the Chapter make more of an effort to connect with the student AIA in Gainesville.
