1. Call to Order: 5:45 PM.

- **2. Adoption of the Agenda:** The agenda was presented. A motion was made, seconded, and carried to adopt the Agenda.
- **3.** Reading & Approval of the Minutes: The December 11, 2017 meeting minutes were presented at this meeting. A motion was made, seconded, and carried to approve the December 2017 minutes.

4. Officer's Reports:

A. Treasurer's Report: Adam presented the 2018 Budget.

5. Committee Reports:

A. Program Committee:

1. Continuing Education: Mick has lined up 7 lunch & learn presenters. The first presenter is booked at Napolitano's. Mick is looking into other locations for lunch & learns including Working Food, which could be the possible location for February.

The two hours of building code credit is a desired continuing education credit for the AIA to host. Because this isn't offered by a vendor, it will require some cost to be covered by the AIA.

Bill reported on the Grow Your Business Presentation that Lila from the city would present. Because the city isn't a vendor, in order for this to be a lunch and learn, this would require money. The board would like to table this until after the 2 hour building code credit is scheduled.

Florida Building Code Changes Meeting: Ricardo is handling this meeting with the city where there will be time to discuss and ask questions about the most recent changes to the building code. Included in this meeting will be digital signing and sealing.

- **2. Masterpiece Collections:** Mick to help with arrangement and promotion. Possible venue options are the Hippodrome and the Heartwood Sound Studio.
- **3. Art by Architects:** This could be funded by the community outreach money in our budget. The event could be held at the Community Design Center.
