1. Call to Order: 5:31 PM.

- **2. Adoption of the Agenda:** The agenda was presented. A motion was made, seconded, and carried to adopt the Agenda.

### A. Program Committee:

- **B. Membership Committee**: After we receive the list of non-renewals, we can begin the process of calling individuals to encourage renewal.
- **C. Sponsorship Committee:** Adam reported that he is working on a list of potential sponsors for the golf event, starting with past sponsors. Adam is working to broaden our sponsorship base. Mick and Adam both have spreadsheets of potential sponsors started.

- 5. SAP Structural Assessment Program, May 11th all day at the Gainesville Golf and Country Club. It will cost \$175 to rent it for the day. Cydney has set up an event-zilla. Adam will help Cydney finish setting up the event-zilla. The AIA will cover the cost of food. AIA members will pay \$120 at the time of sign up. Non-AIA members will pay more. It will count for 6 hours of hsw credits and the SAP certification.
- 6. FLW Plaque Bill Warinner continuing to coordinate the plaque which will bear something along the lines of "plaque sponsored by AIA Gainesville."
- 7. Board Insurance check was mailed last week but has not been cashed yet.

### 7. New Business:

- A. Allied Membership: We are listed as charging \$100 for a local membership, which is the lowest fee in the state. It is suggested we raise this to be \$150 to be closer to other local memberships. Other chapters keep their allied memberships actively involved by some of the following: 1) a monthly breakfast meet & greet. 2) allied members are listed on the local AIA chapter website by specification section. 3) A reverse trade show, where members have tables and allied members visit from table to table. (We could have a reverse trade show where we present our projects). 4) An allied member committee 5) Auction off lunch with an architect to allied members 6) Have a non-voting allied members on the board. \$
  - \$150 will be the new set price for a local allied membership which will be posted on our website.
- B. Component Accreditation Due on January 15th. This accreditation is for three years.
- C. People Choice Awards Nominations will be asked for in the next six weeks. Must have been completed within 5 years within our component.
- D. Member Involvement Ideas: 1) Have another meet & greet at Cypress & Grove. 2) Design Competition for a "bird house" or "tiny house" which could be open to student and members Eva to put together the birdhouse competition which will be presented at Cypress & Grove. Florida Foundation is interested in getting involved in outreach events and could help with man power at our events.
